Carmel Clay Parks & Recreation is seeking feedback on three proposals for the development of Bear Creek Park on 27 acres at the southwest corner of 146th Street and Shelborne Road.

Park designers with consultant SmithGroup presented the proposals and gathered public input at a community meeting held Jan. 25 at West Park. CCPR and SmithGroup will continue accepting feedback on the proposals online at carmelclayparks.com/parks/bear-creekpark. A video of the presentation is available on the website as well.

CCPR will use the feedback gathered to develop a master plan, which will be presented to the parks board for input and final approval. The final plan may include elements from more than one proposal.

Each proposed plan features development in approximately 20 percent of the park with the rest remaining ecological areas.

Bear Towers

The Bear Towers proposal features two towers that would rise above the tree canopy. Accessible by ramps rather than stairs, the towers are inspired by historic fire towers in state and national parks and provide a bird's eye view of the park.

"How you see the site when you're above the site is very different than when you're in the site," said Jacob Blue, a landscape architect at SmithGroup, adding that the towers could include flags or flashing mirrors for park guests to use to communicate between them.

The Bear Towers plan includes a single large building with heating and air conditioning near the north end of the site. It also includes a play and spray area and could include zip lines or a high ropes course. A picnic area is proposed on the south end of the site.

The creek that winds through the park would be largely unaltered in this proposal.

Braided Bear

The Braided Bear plan features a "squirrel's eye" view according to Gregg Calpino, SmithGroup principal, with elevated pathways winding through the tree canopy. It could include slides or zip lines between levels.

It also includes the creation of braids and wetlands off of the creek which could be explored by an expansive boardwalk system that allows guests to get near the water. Certain areas would be designated for creek stomping.

The plan proposes several moderate- to small-sized conditioned buildings, creating a mini-campus rather than a single large facility.

Wandering Bear

The Wandering Bear proposal includes altering the creek to make it longer, which would lead to a more winding trail option compared to the other plans. Play areas, which could include hillside slides and natural climbing structures, could be placed in oxbows of the creek. Guests would be encouraged to venture into the creek to explore.

Bathrooms are proposed on the north and south ends of the site, with the remaining facilities being open-air structures. It would not include a roadway connection through the park. A picnic grove is proposed on the southern portion of the site.

Safety tips

Sledding is fun, but it can be dangerous. Cara Fast, manager at the Riley Safety Store, has some recommendations for keeping safe on the snow.

Always sit facing forward to decrease the risk of a serious head injury. Consider a winter sports helmet.

Ensure the sled is in good working condition.

Dress properly for cold weather. Avoid scarves or other clothing that may get caught. Use a hill that is not too steep and has a long flat area at the bottom to glide to a stop. Don't use hills that end near a street, parking lot, pond or trees.





On this day in history in 1868, the first U.S. parade with floats took place during the Mardi Gras celebration in Mobile, Alabama. Like so much of our culture, Mardi Gras originated with the Romans. Their Lupercalia festival of merriment became "Fat Tuesday," but originated as Carnival, beginning after January 6 and seen as the last chance to indulge before the austerity of Lent. Parade floats were first introduced in the Middle Ages. Churches used pageant wagons as movable scenery for passion plays, and craftsmen with artisan guilds built pageant wagons for their specified craft. The wagons were pulled throughout the town, most notably during Corpus Christi in which up to 48 wagons were used, one for each play in the Corpus Christi cycle.



Bluebird Monitoring

Although bluebird monitoring has not officially started for the season, our volunteer Charlie Murray (neighbor to Central Park West) contributed time to making 12 new bluebird boxes for CCPR. This is the second year that Charlie has made bluebird boxes for the parks and we are so appreciative for him time and talent! \$530.00 worth of material was purchased for the build with materials for building the boxes including wood and deck screws. Within a few days of getting the material to Charlie, he had all 12 boxes built and delivered back to CCPR!

The remainder of the material included sheet metal screws, EMT conduit, and rebar that were purchased to aid in the completion of installing the boxes. The rebar goes into the ground with conduit over the top as the post. The bluebird box gets attached to the conduit using metal brackets that hold it in place.

As spring approaches, we'll assess new locations within the parks to install more boxes. Bear Creek Park as well as the Steckley Property are 2 proposed locations.

Staff visiting West Park for the capital improvement project already noted a male/female pair of bluebirds perching in a nearby oak tree high up on Jill's Hill, undoubtedly looking to nest.

Roll Call; Call to Order & Pledge of Allegiance

Board President Taylor welcomed everyone to the meeting and asked Mr. Rude to call the role. Mr. Rude announced that there was a quorum. Board President Taylor called the meeting to order at 6:03 p.m. and asked everyone to rise for the Pledge of Allegiance.

Public Comments

There were no public comments.

Staff Reports

Assistant Director Baumgartner said that staff reports were included in the Park Board packet. He mentioned that the Strategic Plan Implementation Status Report was included. This report outlines key recommendations of the Master Plan and the Department's progress in meeting those recommendations. For the second consecutive year amidst a pandemic, which had a tremendous impact on the Department, CCPR accomplished much. At this time, Assistant Director Baumgartner provided some details within the Strategic Plan Implementation Status Report.

Assistant Director Baumgartner announced that the Department received a \$20,000 donation from Stephen Furry, in remembrance of his late wife, Amy, who passed away in March 2021 after losing her battle with cancer. Assistant Director Baumgartner first met with Mr. Furry last August to discuss different opportunities to honor Mrs. Furry. Mr. Furry decided to donate \$20,000 toward the future dog park expansion to include an off-leash dog trail into the north woods.

Board President Taylor said he thought the (Monon Community Center) passes looked good. Assistant Director Baumgartner added that the year is off to a good start. Discussion followed regarding Silver Sneakers and keeping information updated on a quarterly basis.

Mr. Kirsh questioned why the graphs for Fund 109 and Fund 108 cover different dates. Assistant Director Baumgartner said manipulation of the data was difficult due to transitioning to new software and the challenges it brings.

Ms. Zheng stated the Finance Committee did not meet last month so there was nothing to report.

Minutes

January 11, 2022 Annual and Regular Meeting

Mr. Rude made a motion to approve the minutes as submitted. The motion was seconded by Mr. Kirsh.

Mr. Garretson questioned the minutes as they did not reflect an answer to his question about achieving cost recovery in 2021 due to staffing levels. Director Klitzing said the minutes are not prepared in the same manner as a court reporter. When there is any discussion, the minutes will reflect that within the minutes.

Board President Taylor said that at any time a Park Board Member can make a motion to amend the minutes. Mr. Garretson declined. Director Klitzing added that the primary means of tracking discussions is via the video. Director Klitzing, Board President Taylor, Mr. Westermeier, Ms. Jackson, and Ms. Kristunas provided additional background and personal observations regarding meeting minutes. Mr. Nolting stated there is no legal requirement to have verbatim minutes. The current practice of using the video is above and beyond what is considered public transparency.

Board President Taylor called for the vote, and the motion was unanimously passed 9-0.

Consolidated Financial Report for December 2021; CCPR P&L Statements for January 2022

Ms. Zheng made a motion to acknowledge receipt of the Consolidated Financial Report for December 2021 and to acknowledge receipt of the P&L Statements for January 2022. The motion was seconded by Ms. Kristunas.

Assistant Director Baumgartner stated that the Department did finish the year with each non reverting fund at 100 percent cost recovery. He commended staff in managing their respective budgets. Ms. Kristunas asked if he could add to the January reports.

Assistant Director Baumgartner said he and Director Klitzing have spoken about ESE and both feel the program is trending in the right direction with attendance continuing to increase. Fund 109 looks good as well, even with general insurance and cleaning expenses which skews the January numbers. All in all, the Department is right on track this year so far.

Board President Taylor called for the vote, and the motion was unanimously passed 9-0.

Claims

Claim Sheet February 8, 2022; Clay Township Claim Sheet February 8, 2022; CCPR Payroll for January 14, 2022 and January 28, 2022

Ms. Zheng made a motion to approve the claim sheet February 8, 2022; to approve the Clay Township Claim Sheet dated February 8, 2022; and to approve Payroll Wages and Liabilities for Payroll Dates January 14, 2022 and January 28, 2022. The motion was seconded by Ms. Kristunas.

Mr. Rude asked about the claim for Ellis Mechanical for repair of The Waterpark leak. Assistant Director Baumgartner confirmed the repair work was completed, and we are ready for the 2022 season.

Mr. Rude asked about payment to the Spear Corporation. Assistant Director Baumgartner replied that this was for a purchase of a pool vacuum.

Board President Taylor called the vote, and the motion was unanimously passed 9-0.

Monetary Gifts, Grants, Partnerships, and Sponsorships for January 2022

Mr. Blake reported receipt of \$20,200.00 for the month of January: \$200 from an anonymous donor for Employee Appreciation and \$20,000 from Stephen Furry, which was discussed earlier in the meeting and will go toward the dog park expansion into the north woods.

Mr. Kirsh made a motion to accept the items as presented, seconded by Ms. Kristunas. On behalf of the Park Board, Board President Taylor offered condolences to Mr. Furry.

Board President Taylor called the vote, and the motion was unanimously passed 9-0.

New Business

Consideration to Purchase Replacement FlowRider Surface at The Waterpark

Assistant Director Baumgartner spoke about the need to replace the FlowRider surface at The Waterpark (photo included in packet). Staff has cleaned the surface thoroughly every year, but the vinyl is starting to show its age. Surfaces tend to typically last eight to 10 years, and we are in year 10 of this amenity. Hydrotech, the manufacturer and sole provider of this surface, provided a quote, and if approved by the Park Board, it will be installed and ready to go prior to opening of The Waterpark.

Mr. Kirsh made a motion to accept the quote from Hydrotech Systems and authorize the Assistant Director of Parks and Recreation to execute a purchase order in the amount of \$41,060.62 in order to purchase new ride surface and safety padding. The motion was seconded by Mr. Rude.

Mr. Kirsh said as a user of the FlowRider, he had noticed the divider was looking a bit tired, and the Velcro appears to be worn out. Assistant Director Baumgartner said this request was for the main ride surface and the pad that comes up over the front. He will seek staff's recommendation on the divider, and if necessary, obtain a cost for the divider.

Board President Taylor asked about obtaining only one quote. Mr. Nolting advised that this would be considered a sole-source purchase and did not require a bid process.

Board President Taylor called for the vote, and the motion was unanimously passed 9-0.

Consideration to Purchase Cabana Furniture at The Waterpark

Assistant Director Baumgartner shared that the cabanas in The Waterpark have been extremely popular. The original furniture is worn out and needs to be replaced (photos included in packet). Additionally, the original furniture provided limited seating for four to six people, while the cabana itself could comfortably hold eight to 10 individuals. Staff recommended moving away fabric cushions and purchase furniture that is easier to clean and maintain. The furniture is commercial quality and is made of wicker material with a pad built in under the bottom side. Also, staff provided a layout to display the proposed seating with the new furniture (photos of proposed furniture and layout included in packet). Anacara Company was selected due to several factors including the only manufacturer that could guarantee availability prior to The Waterpark season.

Mr. Kirsh made a motion to accept the quote from Anacara Company to purchase cabana furniture in the amount of \$60,390.00. The motion was seconded by Ms. Kristunas.

Mr. Kirsh asked if staff had a ballpark estimate of revenue generated from the cabanas. Assistant Director Baumgartner said it fluctuates each year. He said last year, revenue was about \$75,000 so the cabanas have definitely been a big success.

Mr. Garretson asked for clarification on the cushion on the new furniture. Assistant Director Baumgartner reiterated that there is a cushion on the bottom side of the wicker. But there is no fabric cushion. Mr. Garretson asked about disposal of the old furniture. Staff assured him that if discarded, the asset disposal procedures would be followed.

Board President Taylor called for the vote, and the motion was unanimously passed 9-0.

Old Business

Bear Creek Park Master Plan Update

Director Klitzing said he was pleased to report that SmithGroup was in town on January 24th and 25th for two days of public input for Bear Creek. This was the third round of public input. Director Klitzing provided additional information regarding the Bear Creek Park Master Plan process. He encouraged the Park Board Members to visit CCPR's website to view the recorded meeting, slides, and detailed information about the proposed plans. A lengthy discussion followed.

Clay Township Impact Program Updates

Director Klitzing stated construction is proceeding on all projects (see Director's Report). Director Klitzing provided photos of West Park.

Director Klitzing said that the Department has been working with Clay Township and Connor Prairie on the exact location of the pedestrian bridge that is being funded by Clay Township. It appears that the bridge will be close to the river ecology center as opposed to River Road. Also, looking to potentially partner with Delaware Township on the trail connection on Fishers' side, as well as cooperation between the city engineers for Carmel and Fishers.

Attorney's Report

In Mr. Bosma's absence, Mr. Kowalski presented the Attorney's Report.

Working through two property donations. Sunrise on the Monon – waiting on a survey of the property. Albany Village (*mentioned in the Director's Report*) – working with the developer to obtain a signed agreement.

There are no significant updates on litigation matters.

Received a contract for review from Assistant Director Baumgartner for Absorb, a learning management system software.

Continuing to work with staff and engineers on the relocation of utilities for Monon Structure #12.

Mr. Westermeier asked about representation on the HOA Board for Sunrise on the Monon. Specifically, a seat on the board with veto power. Director Klitzing responded in the affirmative stating that this was still non-negotiable and a part of the agreement prior to accepting the park, which is formally named the Vera J. Hinshaw Park.

Director's Report

Director Klitzing said his written Director's Report was included in the Park Board packet.

Director Klitzing stated that in the future, staff will use the same format for resolutions that has been adopted and is now being used by Clay Township. Instead of everyone signing the resolution, responses will be recorded and then one of the officers will attest to the record. This process was discussed with the Park Board President and the Park Board Attorney.

Director Klitzing added that the Department continues to struggle attracting part-time staff, which is the same problem throughout the country. He continued with statistical information and cited open positions.

Director Klitzing elaborated on one of the biggest challenges which is keeping lifeguards through the post season. Historically, the Department has tried to keep The Waterpark open until Labor Day, which has been a tradition in and throughout the Midwest, but more and more park systems, including Indianapolis, have started closing their pools when the kids go back to school. The Department is finally at that situation where we can no longer safely operate The Waterpark once the kids return to school resulting in the last day of operations to be Sunday, August 7th. Director Klitzing expanded on this challenge.

Board President Taylor said he had provided to Assistant Director Baumgartner the name of a company that might be able to provide the necessary staffing. He added that staff should reach out to this company prior to making a final decision on the end of the waterpark season, especially since August seems to have the warmest weather and a lot of people, including himself, enjoy The Waterpark on Saturdays and Sundays throughout the month. Assistant Director Baumgartner said that staff had difficulty making connection with the company and asked for assistance. Discussion followed.

Mr. Garretson asked about the status of Orchard Park and if Bob Sweeney had been involved in any of the discussions with the schools. Director Klitzing said Mr. Sweeney had not been involved. Mr. Garretson stated that the present expansion of the library facility will be its last, but that did not mean expansion will be over and that future expansions would probably be through branches as opposed to the main library. He added that the southern part of the Township needed service and perhaps both the parks and the library could go in together to utilize the Orchard Park facility. Director Klitzing said he would be happy to suggest such to the school, however, ultimately, the school has the final say since it is their property.

Ms. Jackson said she had nothing to report.

Plan Commission

Mr. Kirsh stated he would be happy to answer any questions from the Park Board. Due to the recent snow, the comp plan meeting was postponed.

SUMMARY:

Carmel Clay Parks & Recreation (CCPR) is working with contractors to finish park improvements at Lawrence W. Inlow and Meadowlark Parks made possible by the Clay Township Impact Program (CTIP). One of the many upgrades being made at both parks is the addition of pickleball courts.

As part of CCPR's due diligence, staff conducted research on industry best practices with regards to noise created from the pickleball paddles striking pickleballs. Staff concluded that when residential housing is within 500 feet of courts it is recommended to provide some type of noise mitigation. After exploring options and conferring with colleagues experienced in designing pickleball courts, staff determined the best solution would be to install a soundproof acoustic fence barrier, otherwise known as an acoustifence, along the perimeter of the courts that face residential housing. Acoustifence is a 1/8-inch thick, heavy mineral-filled viscoelastic acoustic barrier material.

CCPR requested quotes from authorized dealers that could provide this material and serve the Carmel area. The following quotes were received by the March 3, 2022 deadline:

Acoustiblok: \$42,179.01Sport Surface: \$74,000.00

Staff recommends approval of the Acoustiblok quote in the amount of \$42,179.01. All quotes include a two-year warranty and shipping. Installation will be completed by CCPR staff. It is anticipated that the product will be received and available for installation prior to re-opening the parks.

SUMMARY:

Through Resolution G-2019-005 adopted on July 9, 2019, the Park Board approved the Agreement with Clay Township (the "Agreement") to implement the Clay Township Impact Program, which included renovation of West Park and authorized SmithGroup as the architect for the project. On December 10, 2019, the Park Board authorized expansion of the West Park project by contributing an additional \$2.5 million to the project, including assumption of SmithGroup fees associated with the expanded scope of services.

Due to a variety of factors, including poor soil conditions and the impact of COVID-19, the project has taken longer than originally anticipated. To cover services for this extended period, SmithGroup has requested additional compensation totaling \$17,430, which has been reviewed and approved by the Township's Owner's Representative and Trustee Doug Callahan. The additional costs will be covered by both bond proceeds (\$7,507.70) and Park Board funds (\$9,920.30). Even with these additional expenses, the project is not anticipated to require additional funding from the Park Board above the \$2.5 million that has already been committed.

Pursuant to the Agreement and its Responsibility Chart, the Park Board must approve an Architect Agreement Amendment with the Township that affects the Board. Accordingly, the provided amendment is attached for your review.

THIRD AMENDMENT TO AIA DOCUMENT B101-2017 STANDARD FORM OF AGREEMENT BETWEEN OWNER AND ARCHITECT

This Third Amendment to Agreement ("Third Amendment") amends the AIA Document B101-2017 Standard Form of Agreement between Owner and Architect dated June 5, 2019 (the "Agreement") by and between Clay Township of Hamilton County, Indiana as Owner ("Owner") and SmithGroup, Inc. as Architect ("Architect") (collectively the "Parties") as previously amended by the Parties on December 10, 2019 (the "First Amendment") and on June 5, 2020 (the "Second Amendment").

WHEREAS, the Parties entered into the Agreement for the design, construction and renovation of existing park facilities at West Park located at 2700 W. 116th Street, Carmel, Indiana to continue the development of the park's Master Plan (the "Original Project") through the original scope of work provided for in the Agreement (the "Original Scope"); and

WHEREAS, on August 8, 2019 Owner issued a notice letter to Architect (the "Notice") directing the Architect to consult the Director of the Carmel Clay Parks Department on all matters, approvals and notifications which are required to be presented to the Owner's Program Manager under the Agreement; and

WHEREAS, the Parties entered into the First Amendment in order to incorporate a Project Expansion and Expanded Scope as defined in the First Amendment to be paid from funds available to the Carmel/Clay Board of Parks & Recreation; and

WHEREAS, the Parties amended the Fixed Fee for the Original Scope and the budget for potential permitting efforts as defined in the Second Amended; and

WHEREAS, the period of construction has exceeded the allowed duration provided in §4.2.3 of the Agreement; and

WHEREAS, to complete the Architect's services within the total compensation established by the prior Amendments, the Parties have agreed to amend the Architect's scope of services and also to revise the budgets allocated to fixed fee and reimbursable expenses.

NOW THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Owner, the Architect and the Park Board agree as follows:

- 1. Recitals. The foregoing recitals are incorporated into this Agreement as if set forth in full.
- 2. <u>Scope of Services</u>. The Architect's Scope of Basic Services attached to the Agreement as Exhibit "B" (the "Original Scope") as revised by §2 of the First Amendment, is hereby updated and supplemented by the Scope of Services set forth in the December 13, 2021, letter from Architect attached hereto as Exhibit "A" (the Amended Scope").

- 3. Original Scope Fee and Reimbursable Expense Limit. Pursuant to §11.1.1 of the Agreement, §4 of the First Amendment, and §2 of the Second Amendment, the Owner and Architect hereby revise Architect's Fixed Fee to the amount of Three Hundred Eighty-Five Thousand Seven Hundred Twenty-Five and 70/100 Dollars (\$385,725.70) (the "Revised Fixed Fee") payable in accordance with the terms of the Agreement. The Parties may further revise the Revised Fixed Fee by written agreement. Pursuant to §11.8 of the Agreement, the Owner and Architect hereby revise the Compensation limit for reimbursable consultants and expenses for the Original Scope to the amount of Twenty-Two Thousand Four Hundred Ninety and 30/100 Dollars (\$22,490.30) (the "Revised Reimbursable Expenses") payable in accordance with the terms of the Agreement, after which revision the balance remaining as of Architect Invoice #0159703 dated January 4, 2022 is \$11,257.44.
- 4. Expanded Scope Fee and Reimbursable Expense Limit. Pursuant to §5.1 of the Second Amendment, the Owner and Architect hereby revise Architect's Fixed Fee for the Expanded Scope to the amount of Two Hundred Fifty-Four Thousand Nine Hundred Twenty and 30/100 Dollars (\$254,920.30) (the "Revised Expanded Scope Fixed Fee") payable in accordance with the terms of the Agreement. The Parties may further revise the Revised Expanded Scope Fixed Fee by written agreement. Pursuant to §5.3 of the Second Amendment, the Owner and Architect hereby revise the Compensation limit for reimbursable expenses for the Original Scope to the amount of Five Thousand Seventy-Nine and 70/100 Dollars (\$5,079.70) (the "Revised Expanded Scope Reimbursable Expenses") payable in accordance with the terms of the Agreement, after which revision the balance remaining as of Architect Invoice #0159203 dated December 15, 2021 is \$0.
- 5. <u>Confirmation and Ratification</u>. Except as specifically revised by this Third Amendment, the Parties hereby confirm and ratify the Agreement, as amended by the First and Second Amendments, in every way and incorporate all provisions therein into this Third Amendment. The Parties and the Park Board shall continue to have all rights and responsibilities provided under the Agreement and the Project Agreement as modified by the Notice and as further modified by the First Amendment, the Second Amendment and the Third Amendment. Except as otherwise specifically provided in this Third Amendment, the terms of this Third Amendment shall prevail over the Agreement, the First Amendment, the Second Amendment and the attachments to the Agreement and the First and Second Amendments.

Re Proposed Fee Extension for West Park Construction Administration Services

Dear Lloyd,

As requested in our early November coordination call, we have reviewed the outstanding West Park construction items, along with the most recent Alderson construction schedule provided on November 24, and propose the following amendment to our current professional services agreement. As we discussed, and based on additional input from Michael Klitzing and Kurtis Baumgartner at CCPR, we recommend a reduced construction administration role and focusing our remaining construction observation efforts on the following "unique" elements which CCPR believes are the most critical for SmithGroup and Williams Architects to review in person, as they pertain to design intent, operations and maintenance considerations, and health and safety of the public:

- GRFC wall installation and fence/wall interface
- Water wall plumbing before GRFC wall installation
- Hillside stone scramble and slide installation
- Playground before PIP surfacing is placed, after curbs and equipment is substantially in place
- Water trough and pumps after initial install but before all surrounding elements are placed
- Bridge and abutment guardrail interface
- Trench drains after initial install but before surrounding elements are placed
- Stone Blocks at Building Entry and Limestone Benches along Walks
- Water Park splashpad features and operation
- Shelter and Toilet Building
- Landscape Staking Layout in Central Playground Area
- Punch list visit

As discussed, we are open to any opportunities to bundle the above items and/or combine their respective field review with another project's travel to Carmel. Our amended fee below assumes one such "bundled" visit, given that our other project schedules do not currently align well with Alderson's current schedule for completion of West Park. We are also in agreement that the final inspection to confirm completion of the punchlist should be delegated to the Lochmueller team. Finally, we are supportive of a reduced role in weekly progress meetings (although it would be helpful if minutes were distributed after the meeting to keep us informed) and delegating all change order paperwork to the Lochmueller/CTI team to offset some of the additional costs predicated by the extended construction schedule. We will continue to focus on review and processing of submittals and responding to RFIs as our primary administrative role.

It is still our objective to achieve our amended, remaining scope of work within the resources currently available through our existing agreements, by re-allocating unused reimbursable expenses as needed to address any funding gaps. To clarify why the referenced expense budget is available for re-allocation, it included a sizable allowance for permitting costs based on what we collectively learned in previous West

Park phases that hasn't and isn't expected to materialize in this phase, as well as efficiencies during the design phase from combined travel with other Carmel projects. Based on our anticipated expenses for the remainder of our scope and the absence of these permitting expenses, we believe a significant portion of this allowance can be put back into the project to address other needs. In total between the original Township contract (SG project #11640) and Amendment #1 for the CCPR funded portion (SG project #12169), we estimate that we will only need to expend \$7,050 of the combined \$27,098 remaining reimbursable limit, resulting in an excess budget of \$20,050 that can be reallocated.

The numbers below have been adjusted based on the efforts expended in November for site visits (completed 1 visit by Williams Architects, 1 visit by SmithGroup, and 1 "drop in" visit by SmithGroup when in town for other projects) and submittal/RFIs reviews. Note, several submittals were rejected in November as not meeting the requirements of the Contract Documents (such as the plant material, rejected twice thus far) which requires additional review time.

Amended Scope of Services:

- 1. SmithGroup will provide 7 total progress site visits with a focus on the above items, with one of these visits leveraging other project travel to Carmel to reduce labor costs. Note, this only provides cost savings on travel for the one joint visit combined with other projects from the original scope. These site visits are anticipated to combine review of the following items listed above, based on Alderson's revised schedule:
 - Early January 2022: Water trough and pumps, water source blocks, bridge as set in place on 12/3, hillside scrambles, embankment slide, trench drains at plaza
 - Early February 2022: Robinia post install, curbs at playground, completed trench drains (prior to decorative concrete placement)
 - Early March 2022: Plumbing review prior to GRFC wall installation, building progress
 - Mid-March 2022: GFRC Rock Wall initial installation, Guardrail, Fence, Playground install near completion
 - Early April 2022: GRFC finish coating in progress, stone blocks at building entry, limestone benches, PIP play surface in progress Upper Playground
 - Early May 2022 (Williams): Splash pad start up and operation, Shelter and Toilet building
 - Early May 2022 (SmithGroup): GRFC wall finalization, PIP play surface in Lower Playground, landscaping, overall finishing of project work
- 2. SmithGroup will also attend one visit for a Substantial Completion walkthrough (anticipated mid to late May 2022) and will generate a punchlist for work to be corrected or completed. Please note, the reimbursable expense budget we are holding on the project also includes a substantial completion visit by CCPR's accessibility consultant (WT Group) which will need to occur in May 2022 in coordination with our visit. This amendment removes the final inspection site visit from SmithGroup's scope, assuming that Lochmueller and CCPR staff would be able to verify and accept the completion of punchlist items identified during SmithGroup's substantial completion walk through. Thus, in combination with the progress visits listed above, this approach eliminates one final visit plus travet time from one progress site visit from SmithGroup's original contract.
- 3. SmithGroup will be compensated for our increased, completed design work associated with Alderson's retaining wall-related construction deficiencies from Summer 2021.
- 4. SmithGroup will extend RFI and submittal review as well as review of progress meeting minutes through the end of May 2022 targeted substantial completion date and provide record document review anticipated in June 2022. This amendment removes change order review/processing and

progress meeting attendance/participation from SmithGroup's scope, assuming that the Lochmueller/CTI team will be able to lead these efforts and provide minutes and direction for any items needing our attention.

Compensation:

As previously noted given the schedule overrun on the project, the hours we had originally budgeted for administration to facilitate RFI's, attend construction meetings, etc. have already been spent, and our remaining unbilled professional fee after November invoices were issued is \$17,040 (total of both the Township base contract SmithGroup project #11640 and the CCRP contract extension SmithGroup project #12169). The additional cost of the above Amended Scope of Services is \$17,430, for a total remaining contract value of \$34,470. We recommend that this amount necessary for the additional services be covered by converting \$17,430 of our total remaining team expense budgets listed above from our two project agreements, and holding the remaining \$2,620 in projected reimbursable cost savings for a rainy day fund for future unanticipated needs. Note, if this strategy is acceptable, we can discuss whether to leave the entire budget to cover our remaining expenses needed to complete the project (estimated at \$7,050) on either the Township or CCPR contract, or if you'd prefer to split the remaining expenses between the two contracts.

Bear Creek Park

SmithGroup is preparing a draft master plan for presentation to the Park Board at its regular April meeting. The consulting team is incorporating input received in previous public meetings, focus groups, and online feedback as it prepares the draft plan. After presentation to the Park Board, the plan will be posted on CCPR's website providing the opportunity for additional comment. Taking into consideration any feedback received, the final master plan is anticipated to be presented to the Park Board for adoption in either May or June 2022.

The Real Estate Donation and Parks and Recreation Impact Fee Credit was received from Lamb Property Developer, LLC on March 1, 2022 for the donation of the approximately 9.3 acres within the Albany Village subdivision. The developer is responsible for installing landscaping and the multipurpose trail, which will connect across Shelborne Road to the south east corner of Bear Creek Park. The trail is envisioned to be the beginning of a longer Bear Creek Greenway. CCPR will work with the developer and Park Board Attorney to close on the property.

Dog Park

Staff are meeting with Michael Krosschell with Weihe Engineers on March 7, 2022 to begin developing expansion plans for the Central Dog Park. Mr. Krosshell was the original designer of the dog park. This planning process is being funding to the generous \$20,000 donation from Stephen Furry in memory of Amy, his late wife. CCPR is looking to expand the dog park by creating a fenced-in, off-leash trail for dog park members within the woods between the existing dog park and Interurban Trail. This expansion will help CCPR further increase memberships to help address the waitlist which is holding consistently at around 400 dogs.

Public AED Program

CCPR continues to meet at least monthly with the City of Carmel to develop a public AED program along the Monon Greenway. This would provide AEDs and Stop-the-Bleed kits in kiosks at key locations along the Monon, currently targeting Monon and Main Street, Midtown Plaza, Carter Green, and Monon and Gradle Drive. Long term plans envision expanding the program in more locations along the Monon Greenway and within parks throughout the community. Details and a timeframe for rollout are still being developed, but the City is modeling plans after a very robust program in San Diego. More details, including CCPR's specific role in the program, will be forthcoming as plans are finalized.

READI Grant | Hamilton County South River District

Continuing dialogue with the Indiana Economic Development Corporation (IEDC) and representatives from the White River Regional Opportunity Initiative Partnership (WR-ROI) to determine distribution of the \$20 million grant awarded to region. The next meeting is scheduled for March 21, 2022. The Hamilton County South River District, which includes the White River Education and Ecology Center, remains in the running for potential funding, although no final decisions have been made. Projects eligible for funding significantly exceed the \$20 million grant, so some projects may need to be deferred for consideration in the anticipated next round of READI grants.

Vera J. Hinshaw Park

Old Town Design Group has engaged a surveyor to provide an updated survey for the approximately 1.98-acre parcel located within the Sunrise on the Monon development and along the Monon Greenway. This is the last outstanding item that is needed before closing on the property. A closing is anticipated this spring or early-summer.

White River Greenway

Met with Conner Prairie on March 1, 2022 and agreed upon in principle the preferred route for White River Greenway on Conner Prairie's property. This will allow SJCA to finalize the 60% design development plans and identify the specific location of necessary easements for the trails, which are subject to approval from Conner Prairie's governing boards. We will learn this month from IDNR if the White River Greenway North Extension is selected for a Next Level Trails grant, which would allow construction of the trail to begin this year.

Met with SJCA on March 3, 2022 to review preliminary findings of the Archeological Field Investigation, which is being completed as part of the design development plans. As anticipated, Native American relics have been found in several locations along the route of the proposed trail consistent with temporary settlements (i.e., weekend camp sites, hunting expeditions, etc.). These findings are requiring extra digs, which will likely increase the cost of the study, but none of the discoveries to date will impact the ability to construct the trail. The investigation is anticipated to be completed the week of March 7th and the final report received shortly thereafter. CCPR is dedicated to complying with all applicable laws and regulations if any items of significance are identified.

CCPR is in the process of securing the two appraisals for the approximately one-acre parcel located at 12085 River Road, Carmel, which would allow the extension of a perimeter trail connecting River Heritage Park to River Road Park. Upon receipt of the appraisals, the Director, Park Board President, and Park Board Attorney will prepare a formal offer to purchase the property in compliance with Indiana Law and the authority granted by the Park Board.
