JoNell Stevenson's life centers around wellness and creating memories. At 67 years old, her dedication to fitness is essential to maintaining her goals while living with a chronic disease and more than one troublesome diagnosis. It is the mental balance that maintains her strength.

"I need it, it's part of my wellness. It's part of my life," she said.

The Carmel resident learned she had blood cancer, Hodgkin's lymphoma, in 1992. After enduring chemotherapy and participating in an invasive medical trial, she was cancer free.

Over the following years she maintained a fitness plan, with regular doctor visits commending her incredible health. Returning home from cycling one day in 2018, she noticed a small lump. Shortly after, Stevenson was diagnosed with stage 3C ovarian cancer, with a type of tumor that is difficult to detect. According to Stevenson, it is rare for an individual to have two different types of cancer. She was shocked by this diagnosis and considered whether the doctors were looking at the right medical records.

To prevent further tumor attachment, Stevenson underwent a laparotomy to remove all organs she could live without. An aggressive six months of chemotherapy had the cancer under control, but the discovery of a small nodule in 2022 required more treatment.

After yet another six-month round of chemotherapy, Stevenson needed a break to rethink what she wanted for her life and her family. Her doctors agreed that a 6-week (2-cycle) break in the treatment was a positive strategy. It would let her body rest and allow her to regroup physically and mentally and make decisions from a logical standpoint rather than emotional.

"What was important to me was making memories with the people I love," Stevenson said. "I still try to continue to make memories with those special people in my life. My medical team knows how important that is to me and are very supportive."

Stevenson credits her palliative care doctors for helping her through her journey with the chronic disease. They encourage her to share her inner struggles, understand what she is going through and are involved in helping her make informed decisions. Additionally, her support system includes her family, husband of 42 years, son and daughter, as well as her church community and friends at the Monon Community Center, which she visits frequently to strengthen and stretch her body.

"No matter what challenges have come up for me, they have always had the strength to be by my side," she said.

Maintaining control of her physical fitness has greatly contributed to her overall wellness journey. The Monon Community Center has been invaluable, she said. Weeks that she has treatments are harder for her physically, so she elects to take yoga and stretching classes, then rotates in cycling and aqua fitness as well as walking and weights.

Within the Carmel community, Stevenson, a retired middle school science teacher, enjoys attending Civic shows at the Palladium, visits the farmers market, never misses a CarmelFest Fourth of July parade and often takes advantage of the many activities in the downtown arts district. At home, she loves to tend to her flower and vegetable gardens, read, cook, restore antique furniture and paint.

"You have to live life to the fullest while you are here, and no one knows what that time frame is," she said. "If you use that wisely it will seem complete."

This award recognizes a parks and recreation agency for its effort to provide inclusive opportunities and programming to their community. CCPR received the award for its adaptive Murder Mystery Social, a drama therapy-informed program series designed for individuals with disabilities.

"I am tremendously proud of my team and honored to receive this award," CCPR Inclusion Program Supervisor Kelvin Solares said. "CCPR is dedicated to providing innovative and engaging programming for individuals of all abilities and we look forward to offering adaptive programs like Murder Mystery Social in the future."

The one-of-a-kind series gives classic murder mystery dinner parties a personalized spin with drama therapyinformed activities, custom-built sets, and catered food.

Murder Mystery Social was created by drama therapist and CCPR staff member Deborah Fisher.

"Drama therapy uses theatre techniques to help participants work through their issues in a safe and meaningful way," Fisher said. "Role-playing and improvisation provide participants with the freedom to explore and express emotions without fear of being judged, improving their well-being and interpersonal skills."

Rather than purchase a pre-made murder mystery party kit, Fisher designs each program's theme and characters herself. Since joining the team in 2019, she has developed close relationships with the CCPR adaptive community. That allowed her to tailor each mystery story to participants' interests and strengths while also challenging them to get out of their comfort zones.

"Even if participants don't want to play a character or feel too shy to role play, they can still have a fun night-out





with their friends!" Fisher said.





# Doc Dillon was one of the great ones

Hamilton County lost one of its greatest last week when Dr. Jim Dillon passed away at the age of 83.

Doc Dillon was a true leader in the medical field and local government. He was born and raised in Noblesville where his family has deep roots.

He graduated from DePauw University and the IU School of Medicine before serving two years in the U.S. Navy, then returning to the IU Medical School to become a professor. He took a major role in establishing the Interventional Cardiology Program and served as its director until 2004.

In Marion County, Jim joined the Wayne Township Volunteer Fire Department, always promoting emergency medical services and eventually serving on the Indiana Emergency Medical Commission, even chairing the commission for six years.

In 1985, Jim and his wife, Sue, moved to Carmel. Within a few years, he and Sue were instrumental in creating the award-winning Carmel Clay Parks system. Jim also served for 17 years on the Clay Township Board, always supporting the fire department and its emergency medical service.

He also served a year on the Hamilton County Council. Jim was always modest about his accomplishments, but certainly must have approved of his township board successor, Matt Snyder, for taking a leadership role in continuing a legacy of promoting park expansion and fire department facilities.

Jim was always encouraging to this writer in matters brought to the readers' attention in the *County Line* column. While it may sound trite to say "he will be missed," but in the case of Jim Dillon, it is so extremely true.

## SUMMARY:

Provided for your review and consideration is a proposed amendment to the 2023 Salary Resolution (Resolution No. B-2023-004) as last approved by the Park Board on September 12, 2023. The amendment adds a new Section 11 to allow CCPR employees to receive a one-time payout of remaining Sick Leave grandfathered from a legacy policy.

Sick Leave was eliminated from CCPR employees paid leave accrual options in 2011 based on a recommendation report delivered at the 11/9/10 meeting which the Park Board accepted. Since that effective date, no employee has been able to gain any additional Sick Leave. Employees with hours remaining in their banks at this time were able to keep those hours for future use. CCPR currently has five employees with remaining grandfathered Sick Leave in their banks.

This year CCPR is finishing its transition to a new Human Resource Information System to manage items such as payroll and benefits. It is advantageous to eliminate this benefit for the five grandfathered staff so system administrators do not have to manage Sick Leave independent from the rest of the department. Additionally, Park Board legal counsel has assisted CCPR in drafting a new Employee Handbook to be rolled out to staff in January. Paying out this remaining legacy bank will allow CCPR to remove mentions of Sick Leave throughout the handbook creating consistency department-wide pertaining to non-insured benefits.

The total base salary payout will equal \$31,982.05 plus any applicable taxes and benefit costs.

If approved, the payout on remaining Sick Leave will occur before the final payroll in December and be reflected in the December 2023 financials.

Because the proposed payout will impact the compensation of affected employes, all of whom have been with the department 12+ years and at or near the maximum compensation identified in the 2023 salary resolution, it is necessary to amend the current resolution to provide a one-time exception authorizing the payout. Under Indiana law, the Park Board must at least annually pass a resolution establishing the maximum compensation for all positions but has the latitude to make amendments as needed. The proposed amendment will not change the employee's base salary, which is used to determine eligible merit increases or increase the maximum pay rate authorized for their respective positions.

## **RESOLUTION NO. B-2023-006**

# A RESOLUTION OF THE CARMEL/CLAY BOARD OF PARKS AND RECREATION AMENDING 2023 SALARIES AND WAGES RESOLUTION TO PROVIDE PAYOUT OF SICK LEAVE

WHEREAS, the Carmel/Clay Board of Parks and Recreation (the "Park Board") is a political subdivision created and authorized to administer the Carmel/Clay Department of Parks and Recreation (the "Department") pursuant to that certain agreement entitled "Interlocal Cooperation Agreement" signed by the respective authorized officials of Clay Township, Hamilton County, Indiana and City of Carmel, Indiana on July 30, 2002 and effective January 1, 2003, as amended from time to time; and

WHEREAS, the Park Board is vested with the authority to exercise general supervision of and make rules for the employees of the Department; and

WHEREAS, the Park Board is vested with the authority to fix compensation of its officers and personnel; and

WHEREAS, the Park Board amended its paid leave system on November 10, 2010 eliminating Sick Leave as a benefit, but retaining the holdover balances of employees with accrued and unused Sick Leave; and

WHEREAS, the Park Board previously approved and adopted Resolution No. B-2023-004 Amending Established Salaries and Wages for 2023; and

WHEREAS, the Department is within good financial standings to make a one-time payout of remaining Sick Leave balances of affected employees for this legacy benefit; and

WHEREAS, the Park Board has determined that there is a need to amend the 2023 salaries and wages resolution to include the additional compensation received by Department employees in the form of Sick Leave Payout.

**NOW, THEREFORE, BE IT RESOLVED** by the Carmel/Clay Board of Parks and Recreation that the maximum salaries and wages of the officers and employees of the Department, set forth in Exhibit "A" in Resolution No. B-2023-004, is further amended to add Section 11 as follows:

### Section 11 – Sick Leave Payout

Pursuant to the conditions set forth in Resolution No. B-2023-006, eligible Department employees shall be compensated for the full remaining balances within their respective Sick Leave Bank. This one-time payout is independent of their respective maximum bi-weekly or hourly salaries set forth in Resolution No. B-2023-004.
